**AGREEMENT FOR EXCHANGE OF CONFIDENTIAL INFORMATION**  
**Non-Disclosure Agreement covering: "Hearing Healthcare Recruitment Services and all other services related to Healthcare Recruitment"**

Our mutual objective under this Agreement is to provide protection for confidential information while maintaining our ability to conduct our respective business activities. Each of us agrees that the following terms apply when one of us (Discloser) discloses Information to the other (Recipient).

This is an Agreement, effective on \_\_\_\_\_, between The Bridge Recruiting Group LLC. (here-in after referred to as "BRG"), and \_\_\_\_\_. (Here-in after referred to as "Provider or Candidate"). It is recognized that it may be necessary or desirable to exchange information in the pursuit of mutually beneficial business activities associated with Hearing Health Care Provider Recruiting and job placement of one or more Hearing Health Care Providers. It is understood and agreed to that the below identified discloser of confidential information may provide certain information that must be kept confidential. To ensure the protection of such information, and preserve any confidentiality necessary, it is agreed that:

1. The Confidential information to be disclosed can be described as and includes:
  - a. Any and all business information related to the recruitment and job placement of Hearing Healthcare Providers.
  - b. Any and all job descriptions related to a job opportunity.
  - c. Any documents, agreements, resumes, CV's, etc. associated with the recruitment of a Hearing Health Care provider.
  - d. Any and all pertinent materials, information or trade secrets.
  - e. These above items include any past, current or future confidential information at the time of this disclosure.
2. The Recipient shall limit disclosure of Confidential Information to having a need to know. The Recipient and affiliates will not disclose the confidential information obtained from the Discloser unless required by law.
3. This Agreement imposes no obligation upon the Recipient with regards to any Confidential information (a) that was in the Recipients possession prior to the receipt of the Disclosure; (b) is or becomes a matter of public knowledge thru no fault of the Recipient; (c) is rightfully received by the Recipient from a third party not owing a duty to the Discloser; (d) is independently derived by the Recipient.
4. This Agreement represents the entire agreement between the parties concerning the disclosure of Confidential Information. Any addition or modification to this Agreement must be made in writing and signed by both parties.
5. If any of the provisions of this Agreement are found to be unenforceable, the remainder shall be enforced as fully as possible.
6. Beach of this Agreement may be enforced thru legal measures as deemed by the Bridge Recruiting Group. Any and all legal fees and or cost associated with legal actions will be paid for by the Recipient.

Wherefore, the parties acknowledge that they have read and understand this Agreement and voluntarily accept the duties and obligations set forth herein.
